The Action has proved to be highly successful. The meeting in Turkey attracted 71 participants: 40- eligible for reimbursement and the rest (who were WG members) had to cover the transportation and accommodation at their own expense. Their willingness to pay their own expenses further shows the importance of such meetings in promoting collaborative networking and achieving our aims.

The current meeting, with the amended budget, was able to expand its scope and attracted over a 100 participants. 50 MC members were eligible for reimbursement and 30 WG members and poster presenters were eligible for the Malta meeting, The other participants attended the meeting at their own expense showing yet again the importance of such meetings in promoting collaborative networking and achieving our aims. We were very pleased that the amended budget made it possible to reimburse so many ESRs this time. A dissemination event for BISLI attracting over a 100 practitioners & trainees from Malta will take place on Thursday, December 1st, with speakers from the Action (Laida Restrepo, Elin Thordordotir & Kirsten Schraeyen).

6. STSMs status, applications (words by Laurie Tuller)

STSMs are a very successful tool. A total of 21 STSMs were financed in 2011, as a result of four different calls which were sent out (January 31, June 5, August 31, and September 30). This amounted to 20 300€. Of the 21 grantees (3 men and 18 women), 18 were awarded to early researchers (no PhD or PhD date within the last 10 years), which is 84%. The vast majority of STSMs were devoted to projects directly related to action goals. Grantees came from 10 different countries (13 different labs) and went to 8 different countries (13 different labs). The action was able to finance all applications made (except for one which had been financed by another action source), and, following the guidelines set at the meeting in Turkey, amounts requested were more reasonable and therefore each request could be met entirely. The three STSM rounds completed since the Turkey meeting yielded 13 STSMs. Total STSMs budget was 20 310.00 EUR

The new STSM deadline is December 20, 2011, for STSMs from January 1st, 2012 till May 31st 2012. The estimated budget is 7500 EURO.

STSM applications should follow the general guidelines of this Action: the cheapest transportation and the cheapest accommodation available.

7. Publications

Please remember to update us with new publications related to the action's activities.

- COST would like to see joint publications (at least two different research groups from the Action) as soon as possible. This need not necessarily report new work, and can be limited to a comparative work based on presentations which were done

in the past years or any other kind of collaboration (e.g., a paper which was supported by an STSM). Multi-authored writing teams should be encouraged and we need not wait four years to publish the work which emerges from the action.

- Publications – We need to make a clear distinction between Action-related publications (which we had so far) and Action-supported publications (where at least some of the content or the possibility to write it together emerged from the Action's networking). Books and Special Issues of journals are valued by COST more than papers, but they clearly understand that papers often count more for promotion in academia.
- Members of the action who want to initiate a book or a special issue (better) should let the Chair know about it before approaching publishers and contact journals about dates. Please keep in mind that most publishers would want to know what the content is, so you might want to have an idea of which papers you expect to have in. Some possibilities raised at the SG meeting were Linguistic Approaches to Bilingualism (LAB), IJLCD, Journal of Communication Disorders as well as Multilingual Journal of Communication Disorders. Topics could be within a WG or across WGs.
- Publications policy: The guidelines for publication policy as approved in Brussels are:

All named authors should meet conditions 1, 2, and 3.

- 1) They must make substantial contributions to conception and design, or acquisition of data, or analysis and interpretation of data;
- 2) They must be involved in drafting the article OR revising it critically for important intellectual content;
- 3) They must give final approval of the version to be published.

Fulfilling all these conditions is a necessary condition to be an author. Order of authorship should be decided on the basis of importance of contribution and otherwise alphabetically

- Name and authorship of parental questionnaire (BISLIQ/BIPAQ) – Laurie Tuller will contact those who made substantial contributions to its conception and design, and will then circulate the reference before adding it to the questionnaire itself. The questionnaire will be available on the webpage in the closed section with exact instructions on how to cite it. People who want to translate it to another language should approach Laurie. In the translation they can be the authors but they must make reference on the first page to the COST Action questionnaire and its authors.

In the future the questionnaire will be available to a wider audience who will need to register online in order to get it. **This is a non-profit dissemination activity.**

- Pictures used in the Action are usually a property of the member who made them available to the group. In general there is no restriction on using them for research within the Action for the purpose they were made, but any activity outside the Action has to be coordinated with and approved by the owner.
- If you publish a paper based on any COST activity (e.g., STSM) do make sure to add in the acknowledgement: "The writing of this paper was supported by COST Action IS0804 "Language Impairment in a Multilingual Society: Linguistic Patterns and the Road to Assessment (www.bi-sli.org)".
- If the paper is based on a design or tool developed within this COST Action we suggest: "The design/tools for this study is/are based on the work done in COST Action IS0804 "Language Impairment in a Multilingual Society: Linguistic Patterns and the Road to Assessment (www.bi-sli.org)". The authors of the design/tool and the relevant WG should also be acknowledged. If the design was developed outside the Action please acknowledge the source.
- If the paper is an outcome of the Action please use: "This research was conducted within COST Action IS0804 "Language Impairment in a Multilingual Society: Linguistic Patterns and the Road to Assessment (www.bi-sli.org)".

Action IS0804: Language Impairment in a Multilingual Society: Linguistic Patterns and the Road to Assessment

The reporting period runs from the beginning of May 2010 to the end of April 2011 (second year of the Action). The Action has undoubtedly made progress in accordance with its objectives as they were formulated in the proposal and in the MoU. Within each WG, guidelines have been set up for using common tools in order to test the various linguistic and cognitive phenomena.

Three new COST countries have been attracted (26 COST countries now involved), as well as one non-COST country. Early stage researchers (almost 60% of the Action members) have been involved in the activities of the Action through STSMs and workshops. 75 publications related to the Action have been published by Action members since the last report.

This Action is making progress under extremely satisfying conditions.

The only problem remaining, raised once more by the Action chair in her report is the budget limitations which do not allow the Action to develop as it should.

14.2 Fall 2012 (October) – Padua (Chiara Levorato)

Padova is a city of 250.000 people, with 50.000 students, an old university, an old city center. It is half an hour from Venice.

Travel: there are two possible airports: Venice airport 'Marco Polo' and Treviso airport. In both cases there is a bus that leaves from the airport and, with few Euros (4 or 5), arrives at Padova in 45 minutes.

In the MoU we proposed to hold a training school in the third year (2012). The Action will reimburse the lecturers for travel and accommodation and will provide a financial support for a number of students.

LOT summer school (July 2-13) – it is being negotiated by Jan & Anne. Members who think they want to offer a course should be in touch with Jan as soon as possible to suggest a topic for the course. We suggest trying and coordinating with LOT.

14.6 Final conference –Krakow - end of June / early July 2013 – dates to be set in coordination with Zofia Wodniecka through Datumprikker (see below). We anticipate 100-120 participants from the Action.

Julia writes: “for the time being, it is still allowed to hold the final conference within three months after the official Action end date. However, if you opt for that, the event would be handled as pay-as-go (meaning by us here at the office), and your expenses for the whole event (including reimbursements) would have to be limited to 40.000 EUR (and these 40.000 EUR would be deducted from the budget of the last grant year). All in all, I would strongly recommend you to organize the final event within the official time frame of the Action. This gives you much more flexibility.”
